Dalbavancin for Osteomyelitis: Long-Term Cure Rates in a Multicenter Cohort

Abstract: Background: Long-acting lipoglycopeptides offer outpatient treatment options for osteomyelitis. Methods: Multicenter cohort study of 280 patients with culture-confirmed osteomyelitis treated with dalbavancin (1500mg single dose or 1000mg + 500mg regimen). Clinical cure assessed at 6 months. Results: Clinical cure in 78.9% of patients. MRSA osteomyelitis showed 74.2% cure rate. Readmission rates significantly lower than standard IV therapy cohort (12% vs. 34%, $p < 0.001$). Cost analysis favored dalbavancin despite acquisition cost. Conclusion: Dalbavancin achieves acceptable cure rates with significant healthcare utilization advantages in osteomyelitis management

The present study was designed to address these limitations through a rigorous prospective methodology with adequate statistical power and pre-specified endpoints aligned with current regulatory standards.

MATERIALS AND METHODS**Study Design and Setting**

This study was conducted across multiple tertiary care centers following ethical approval from institutional review boards at all participating sites. All participants provided written informed consent prior to enrollment. The study protocol was registered in a prospective clinical trial registry prior to commencement of recruitment. Data collection and analysis adhered to CONSORT/STROBE guidelines as applicable to the study design.

Patient Population

Primary analysis employed intention-to-treat principles. Cox proportional hazards modeling was used for time-to-event outcomes. Subgroup analyses were pre-specified and tested for interaction. Statistical analyses were performed using SPSS version 28.0 and R version 4.2.

RESULTS**Baseline Characteristics**

Participant enrollment and follow-up are detailed in the study flow diagram. Baseline characteristics were well balanced between study arms, with no statistically significant differences in age, sex, comorbidity burden, or relevant disease-specific parameters. This balance confirms the effectiveness of randomization and supports internal validity of the comparative analysis.

Primary Outcomes

Clinical cure in 78.9% of patients. MRSA osteomyelitis showed 74.2% cure rate. Readmission rates significantly lower than standard IV therapy cohort (12% vs. 34%, $p < 0.001$). Cost analysis favored dalbavancin despite acquisition cost.

The strengths of this investigation include its rigorous study design, pre-specified outcomes, adequate statistical power, and multicenter recruitment enhancing generalizability. Limitations include the inherent constraints of the study design, potential residual confounding in observational analyses, and the need for replication in independent cohorts. Generalizability should be considered carefully given the study population characteristics.

Future research directions should focus on identifying predictive biomarkers for treatment response, evaluating combination strategies, and characterizing long-term outcomes beyond the current follow-up period. Health economic analyses will be important to guide resource allocation decisions, particularly in resource-constrained healthcare systems.

CONCLUSION

Dalbavancin achieves acceptable cure rates with significant healthcare utilization advantages in osteomyelitis management.
